## INTRODUCTION

Wayne DeMille, throughout his career with the Ontario Professional Fire Fighters Association (OPFFA), as a member, a delegate, a consultant, a District Vice President and Executive Secretary-Treasurer demonstrated commitment to his community and our Association.

The OPFFA, to recognize Brother Wayne DeMille's commitment to and belief in the OPFFA, awards scholarships of \$1,000.00 each, to deserving students of active members of the OPFFA who are continuing their formal education beyond secondary school.

Five scholarships are awarded annually.

Post secondary education requires a significant financial obligation. The OPFFA recognizes this and strives to assist our member's children in achieving their goals through these scholarships.

The scholarships are awarded to students who have demonstrated a commitment to their school, community and home life while at the same time living up to the same "Code of Ethics" as the members of the Ontario Professional Fire Fighters Association.

If you are an active member of the OPFFA and have a dependent child enrolled in or enrolling in a post secondary institution/program, please consider encouraging your child to apply for an OPFFA scholarship.

Post secondary education shall include, but not be limited to, university, college or a trade or apprenticeship program.

Please note that you are only eligible to receive this scholarship one time. If you have won this scholarship in the past your application will not be reviewed.

**Letters of Reference:**

Provide at least one letter of reference from a community contact, school official and/ or employer

**Community Activities:**

A brief description of your school, community and home life involvement, include activities that demonstrate commitment to your broader community.

**OPFFA - Code of Ethics:**

In 200 words or less explain how you believe your success in post secondary education program will help you strive to exemplify the OPFFA's "Code of Ethics" (attached)

**Deadline for Receipt of Applications:**

All applications must be received by the OPFFA office by the end of business (4:30pm) on June 1<sup>st</sup>.
